Purpose and Effect of Consent Application

The purpose and effect of this application is to convey a parcel of land having an area of approximately 0.4 ha (1 ac) to be added and merged with the abutting property to the south, known municipally as 1274 Shaw Road (County Road 32). The lands to be conveyed are currently used for agricultural crop production.

Once conveyed, the retained farm parcel would be 6.6 hectares (16.3 acres) in size and the enlarged property (1274 Shaw Road) would be 1.21 hectares (3 acres) in size. The applicant has advised that the conveyance would facilitate an expansion to the existing business at 1274 Shaw Road (County Road 32).

Description and Location of Subject Land

The subject lands are legally described as Part of Lot 7, Concession 3 NRT; and Part 2 of RP 33R20080 (geographic Township of North Dorchester), Municipality of Thames Centre. The subject property is located on the east side of Shaw Road (County Road 32) north of Newton Avenue.




