- A March 2, 2023 meeting where the Mayor and Deputy Mayor are invited to provide comments and concerns with the ongoing Attendance Review, as well as general feedback on how it interlaces with their local plans, such as the Official Plan.
- Clarification on the decision-making, focusing on how capital projects such as the West Nissouri school upgrades are ultimately the decision of the Ministry of Education

### B) TVDSB School Names - Lord Dorchester SS (per A. Morell)

### **Verbal Presentation**

The following written report submitted during the meeting.

The TVDSB Committee in relation to School Names recommends that school communities for the following schools be provided with information regarding the life and work of the individual after which their school is named, and that the school communities be invited to provide input on whether the names of their schools should be changed:

1. McGillivray Central Public School Rationale: Although it is unclear whether McGillivray Central P.S. was named after McGillivray Township or directly after Simon McGillivray/the McGillivray family, the name is connected to the fur trade, which destroyed native land and culture, and resulted in Indigenous lives lost. As a potentially harmful representation for Indigenous people, the school community should be given an opportunity to provide input on the school's name.

2. Victoria Public School Rationale: Queen Victoria reigned during a period of significant colonial expansion, which led to the destruction of native land, lives and culture. The school community should therefore be given the opportunity to reflect on, and provide input on the school's name.

3. Sir George Etienne Cartier Public School Rationale: Although Sir George Etienne Cartier's politics may not always have aligned with those of Sir John A. MacDonald, the two men were contemporaries and collaborators. The school

> community should be provided with information regarding Cartier's life and work and have the opportunity to provide input into the name.

> 4. Lord Dorchester Secondary School. Rationale: First Baron Dorchester Guy Carleton's dealings with freed Black slaves loyal to the British in the American War of Independence could be a source of controversy. Also, as an 18th century British army officer and colonial administrator, Carleton's life and work represent Canada's colonial history and may have limited relevance to the Thames Valley community today. However, because the school community (Dorchester) bears the same name, the school community should have the opportunity to receive information about Lord Dorchester and provide input on the name.

5. Montcalm Secondary School Rationale: As an 18th century French soldier Louis-Joseph de Montcalm Grozon's life and accomplishments may no longer be relevant to the school community today. The Committee's review presents an opportunity for the school community to receive more information regarding Montcalm, and to provide input on any next steps with respect to the name of their school.

### C) London Attendance Area Review (per A. Morell) Report - Attached to Agenda

M.Bancroft, and A. Morrell presented a slideshow and provided an overview of the TVDSB report attached to the agenda.

Some additional discussion and clarification include:

- The current proposals all have similar outcomes within Thames Centre.
- A likely outcome of any re-alignment will include grandfathering clauses for students not wishing to switch schools in their final years.
- West Nissouri is recognized as a school with capacity concerns and review for infrastructure assistance by the Boards review.
