- (B) **Bridge Fest.** The Chair verbally reported that Bridge Fest has received a lot of praise. The following points were discussed:
 - The Dorchester and District Lions Club will be selling food at the baseball diamonds for a tournament during the day, and then fireworks in the evening;
 - The London Food Truck Association (LFTA) supplies eight trucks (and a minimum of six will attend), where the vendors decide if they want to attend the event. Yet, the LFTA will not come to an event if other groups are selling food. At this time, the Thames Centre Special Events Committee (TCSEC) will connect back with the LFTA to make sure six vendors will attend, and then decide what is best for Bridge Fest;
 - D. Brown reported that the County has agreed to close the road from Dorchester Road to Bridge Street. The Parks and Facilities Supervisor are notified the group that eight vendors have signed-up for Bridge Fest;
 - K. Elliott has created great posters for social media and we will continue to share to encourage more booths to join;
 - B. Jones has reached out to musical acts, as well as sound equipment, and they have been contacted and will attend on Saturday, September 11, 2021 from 2:00-8:00pm. Each artist will be promoting Bridge Fest on the socials. The Event Trailer will be placed in the same location, by Home Hardware; and
 - The Chair has reached out to JNS Dance, and they will also be preforming at this event.

The Dorchester and District Lions has reached out to the TCSEC to donate money towards the firework celebration. K. Elliott suggested donating \$1,500.00 towards fireworks. It was:
