#### **Council Votes to Change** Fairview Road Speed Limits

Last night Council approved a motion to change speed limits on the north side of Fairview Road in Thorndale. Speed limits will be consistent with those found on the south side of Fairview Road.

The section of Fairview Road which currently has an 80 km/h speed limit would slow down to 60 km/h, and the section that is currently 50 km/h would be changed to 40 km/h. Ward 1 Councillor Tom Heeman, who put forward the motion, noted that this change would improve safety near the Lions Active Living Centre.



# 2024 Fall Economic Update

At last night's meeting, Thames Centre CAO David Barrick presented the municipality's 2024 Fall Economic Update to Council. Some highlights from the document are noted below.



According to data from Middlesex County, the number of people employed increased since last year's Fall Economic Statement. County data shows **500 net new jobs** in Thames Centre, representing an average growth in employment of 5.6% per year over the last two years.




Internal tracking shows that Thames Centre issued building permits within **7.5 days** of receiving a completed application. This exceeds benchmarks set in the Ontario Building Code which require permits to be issued within various timeframes which range from 10 days to 30 days.



The Fall Economic Update shows that revenue collected from building permit fees have increased. Revenue from the first 10 months of 2024 have already exceeded revenue from all of 2023. This is an indication of continued investment in Thames Centre.

#### **OPP Reports 19% Cost Increase**

At last night's meeting, Council heard from Ross Stuart, Commander of the Middlesex OPP detachment, who provided an explanation for increased policing costs that are being charged to municipalities across Ontario. The 19% billing increase for Thames Centre amounts to a 2.9% levy increase. Costs are connected to increased officer pay, and a retroactive pay package, that were negotiated in an agreement with the provincial government.
